Within the broad range of Mr. Johnson's real estate practice is the representation of numerous commercial entities, including the owners of large regional and smaller local commercial centers. He has assisted these clients in successfully dealing

with every aspect of their landlord/tenant relationship, from negotiating and preparing leases to recovering lost rent and damages. Mr. Johnson has authored papers and lectured on commercial summary evictions and unlawful detainers in Nevada. He has even been retained as an expert witness on landlord/tenant issues. His extensive experience in representing the owners of commercial centers has made Mr. Johnson one of Reno's top commercial landlord attorneys.

Mr. Johnson has substantial experience in all facets of civil litigation. In two cases, the judgment nearly covered all of the clients' attorneys' fees (\$1.3 million and \$356,000, respectively). Mr. Johnson has enjoyed particular success in the appellate arena, authoring several successful appeals and writs in high profile and complex cases to the Nevada Supreme Court and the Ninth Circuit Court of Appeals (see *Squaw Valley Dev.
